

PEOPLE DEVELOPER ASSESSOR COURSE

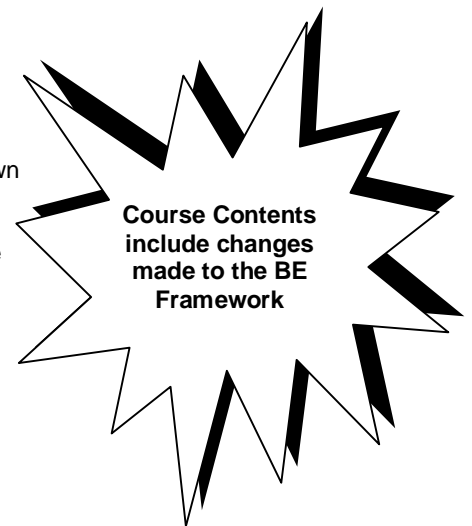
(Based on the New Criteria for Business Excellence Niche Standard (People))

The criteria requirements for the People Developer have been reviewed and revised with effect from 1 August 2006 and the new enhanced Standard has over 60% of new criteria requirements and only 14% of the criteria requirements are retained in the current form. The transition to the enhanced BE Niche Standard (People) while meeting the short renewal deadlines may be a daunting task. This course will give participants a better understanding of the importance of a total and systematic approach to the enhanced Business Excellence Niche Standard (People), and at the end of the course, participants will be able to **assess the gaps and conduct an in-house assessment using the revised PD Standard** in their organization.
